SSS' Special Citation conferred on I-Remit, Inc.

I-Remit, the largest Filipino-owned non-bank remittance service provider, was conferred a Special Citation by the Social Security System ("SSS") for consistently performing as the Best Collection Partner for OFW Remittances during the 2014 Balikat ng Bayan Awarding Ceremonies and Launching of the SSS P.E.S.O. Fund on September 25, 2014.

The SSS Balikat ng Bayan Award was established in 1995 to honor individuals, employers, or organizations that significantly contributed to the SSS' pursuit of its mandate of providing social security service and protection for its members.
